2020 SCHOOL SWIMMING CARNIVAL - YEARS 2*-6

Grose View Public School will be holding our Swimming Carnival on **Monday 17 February 2019** at The Richmond Swim Centre, East Market Street, Richmond. Travel will be by bus.

All children in Years 3-6 attend the carnival. Non-swimming students will be identified with a fluorescent wristband. Please indicate on the permission note below if your child is able to swim 50 m proficiently.

*Children in **Year 2** who are having their eighth birthday in 2020 and can swim 50 m proficiently are welcome to participate in any of the 50 m races. Year 2 students attending **must** compete in a race.

Please return the permission note below with **\$15** (to cover transport and pool entry) **by Friday 7 February.**

Children involved in 100 m races and 8 year races will be leaving school at **9.00 am**. The remaining children will leave school at **9.15 am**. Please ensure students arrive to school by **8.45 am**.

Please note: The individual medley will only be open to students who qualify at a district level in one or more of their 50 m races.

Payments can be made using the Parent Online Payment option (POP) on the school website www.grosvew-p.schools.nsw.edu.au.

An invitation is extended to parents and family members to come along to support our children. Spectators pay a **\$1** admission cost **at the pool for entry**. We will require the assistance of some parents on the day (for example time keeping) and parents are invited to compete against Sport House Captains and Teachers!
