Dress Code:	All students are to wear their Grose View Public School uniform with playing shorts, socks and football boots (moulded studs only).
Food:	Students will need to bring a packed recess and lunch, drink bottle and sunscreen. A canteen or BBQ may also operate on the day if students wish to bring money.
Please Bring:	Students must wear a mouth guard to play and it is highly recommended that they wear head gear.
Additional Information:	If behaviour is inappropriate, parents/carers will be contacted to withdraw the child from the event.
	IMPORTANT INFORMATION
	In the event of injury, no personal injury insurance cover is provided by the NSW Department of Education for students in relation to school sporting activities, physical education lessons or any other school activity. The Department's public liability cover is fault-based and limited to breaches by the Department of its duty of care to students that may result in claims for compensation.
	Parents/carers are advised to assess the level and extent of their child/ward's involvement in the sport program offered by the school, school sport zone,

	region and state school sport associations when deciding whether additional insurance cover is required prior to their child/ward's involvement in the program. Personal accident insurance cover is available through normal retail outlets. Parents/carers who have private ambulance cover need to check whether that cover extends to interstate travel and make additional arrangements as considered appropriate. The NSW Supplementary Sporting Injury Benefits Scheme, funded by the NSW Government, provides limited cover for serious injury resulting in the permanent loss of a prescribed faculty or the loss of use of certain prescribed parts of the body.
